Call To Order:

Approval of Minutes:

Treasurer's Report

Report given by Joe Lorence. The town is scheduled to receive the ¼ (quarterly)ATC payment by July 1<sup>st</sup>.

The 2rd payment from ARPA is scheduled by the end of June.

Scott made a motion to accept the treasure's report, 2rd by Brett, Motion carried.

Old Business:

The crack seal bid was opened from Lakes Asphalt Maintance ,

\$1.45 per pound

Total Cost: \$21,145.00 for all roads.

Fahners:

Complete Total: \$55,676.00 This bid was rejected by the board.

Scott made a motion to go with Lakes Asphalt Maintenance's Company

At \$21,145.00, Brett 2rd, Motion Carried. Contract signed and sent out

Paperwork was returned w/letter sent out to the Fahner's Company – thanking them for submitting a bid and explaining that the township had accepted a different bid.

A bid for mowing the roadside ditches from Jerry Biller's Lawn care Service for \$95.00 per hr.

Brett made a motion to accept the license for 2022, Randy 2rd, Motion Carried

New Business:

Road Maintenance was discussed, Elm Road culverts are plugged and have split in half. Road should be marked so no one goes into the ditch, when traveling this road.

Rocks that are on the north end of Marshall Road need to be removed.

A request came in that a Stop Ahead sign is needed for the North end of Market Rd, Grow Township.

No trespassing signs needed for the pit area, total of 4.

\$1,000.00 cost for one pipe.

Dust Control:

Discussion of where and which chemicals would be best suited for dust control usage.

Scott gave an update on the BIL paperwork that had been completed and submitted for a possible grant of \$360,000.00 that could be awarded.

Town Hall Update:

Scott met with a concrete contractor concerning the cement work needed to update the town hall so that elections could be held here.

Included, Redoing parking area in back 23x23 slab.

Entrances for both the front and back needs to be redone as well as sidewalks in front revamped. \$5,000.00 quote.
